- All minors in Rausser College are available to any current UC Berkeley student in good academic standing.
- A minimum of five courses are required of which at least three are upper division.
- All upper division courses must be taken at UC Berkeley, not all must be taken in the sponsoring department.
- All courses used in satisfaction of a minor program must be taken for a letter grade, unless the course is offered only on a Pass/Not Passed basis.
- The student must achieve at least a C (2.0) average in the courses taken in satisfaction of a minor program.
- Students are allowed one lower division or upper division overlap between their major and the minors listed on this form.
- Additional requirements may vary by minor. Please review the appropriate minor snapshot and consult with the minor advisor.

**Instructions:** Please complete the major/minor overlap check form (next page) and fill out the courses you have completed and/or planned for your major and minor programs. Obtain the signatures from your major advisor, then email the completed form should be emailed to the minor advisor by the Friday of the reading/review/recitation period of the semester before you intend to graduate. Minors are posted on the students' transcript in the 'Memoranda' section, and will not appear on your diploma.
